

Existing Site Plan





Project Phasing

The master plan project will be divided into (4) distinct phases of work.


- Step 1: Nursing Wing Ground Floor Renovation / NPC-4 Work & **Central Plant - Partial First Floor Renovation**
- **Step 2:** Demolish 1954 Building
- **Step 3:** Construct New Administration Building
- **Step 4:** Demolish Health Services Building & New Sitework

Step 1: Nursing Wing - Ground Floor Renovation & NPC-4 Work **Central Plant - Partial First Floor Renovation**


Renovate the ground floor of the Nursing Wing (BLD-00857) and perform NPC-4 work at this level. Renovate part of the first floor of the Central Plant (BLD-00856). All required essential services from the original hospital "1954 Building" (BLD-00854) will be permanently moved into these renovated spaces. All non-essential services from the 1954 Building will be temporarily relocated.





Step 2: **Demolish the 1954 Building**


Add fire wall at perimeter of existing North Addition (BLD-00859). Demolish the original hospital "1954 Building" (BLD-00854) once all tenants have been relocated.





Step 3: **Construction of New Admin Building**

A new 70,000 SF non-OSHPD Administration Building will be constructed where the 1954 Building was formerly located. Temporary occupants in the Health Services Building will be permanently relocated to this new building.




39th AVENUE



Step 4: **Demolition of Health Services Building & New Site Work**

Health Services Building will be demolished once all tenants have been relocated. New site work will add accessible parking and drop-off zone in its former location.


