6.1 Review for Approval the Minutes of the June 1, 2017 Parks and Recreation Commission Meeting

Acting Director Birkeland noted that she received a comment from Chairman Okelo, who could not attend the meeting this evening, disputing a portion of the minutes and asking that the Commissioners defer approval of the minutes until the next Commission meeting. All Commissioners agreed.

6.2 Review and Recommend to the Board of Supervisors Certain Changes to the Coyote Point Marina Fee Schedule

Action: M/S Manneh/Enriquez to bring the fee increases to the BOS. Passes 3-0.

6.3 Consider for Approval a special September Commission meeting to discuss the Commission's Work Plan

This proposal came from Chairman Okelo, who is concerned that the assignments under the work plan were languishing. For purposes of moving things along more quickly, Chairman Okelo would like the Commission to consider setting a special meeting in September just devoted to assignments under the work plan. This would be a full Parks Commission meeting.

Action: M/S Merrilees/Enriquez Motion that the Commission not have a special September meeting. Passes 3-0.

7. Commission Subcommittees

Commissioner Merrilees reported that the Portola/Ohlone Trail is progressing, but it will take a long time to fully implement. The Dog Committee is also moving very well but it is taking longer than was thought. The Dog Committee hopes to have its draft policies out by September but these won't be the final policies.

8. Parks Foundation Executive Director's Report

Executive Director Michele Beasley could not attend today's meeting as she is at tonight's Coyote Nights event.

9. Commissioner's Reports

Commissioner Enriquez reported that, while under care at Stanford Hospital, he heard from several of the doctors that they would very much like to visit San Mateo County Parks. Commissioner Enriquez asked the Commission Clerk, Lori Mrizek, if she would please send him 10 guides to SMC Parks and he will send them to the 9 doctors at the Stanford Hospital, Department of Dermatology. Ms. Mrizek agreed to send the materials to Commissioner Enriquez.

Commissioner Manneh shared that he attended the July Coyote Nights event and it was a really great event. He encouraged others to attend. Commissioner Manneh shared that there will be a town hall meeting on September 20th, regarding the increase in wildlife sightings in our communities. The meeting will be held at the Colma Community Center. Someone from the Peninsula Humane Society will be there to talk about living with raccoons, coyotes and other animals. This meeting will be hosted by District 5 Supervisor David Canepa.
