Hi,

We've had our dog, Scamper, for 13 years. We got her as a one-year-old from the San Jose shelter. Our children grew up with Scamper. We lived in the East Bay and enjoyed the Regional Parks where we could bike while the dog ran alongside. We discovered the wonderful off leash dog parks, Point Isabel and Fort Funston. We never went to State Parks because they don't allow dogs. Now our dog is old, the kids are in college and we live in El Granada.

There are some wonderful spots here too, but we have found San Mateo County to be much more restrictive. Whatever the regulation the common practice here is to allow your dog off leash at places like Surfers' Beach, Pillar Point and Quarry Park. It is lovely!

When 40% of households have a dog it doesn't feel fair that there is so few places for dogs, especially off leash locations. Our dog was totally unsocialized when she came from the pound. I put in a lot of work to have her get used to other dogs, our cats, horses, cows etc. I think the ability to have a dog off leash is very important to make them relaxed and able to relate to other dogs without aggression.

Please make San Mateo County more dog friendly. Most people love dogs, and for kids to grow up with a dog is a wonderful thing. If we can't bring the dog, we won't go, and to keep 40% of the population out of 95% of recreational areas just doesn't seem fair.

Hello, my name is the latest and I'm a resident of Moss Beach and I'd like to highlight a couple of statistics that are useful to our discussions.

- The most recent census statistics for San Mateo County (2010) reflected total households of \sim 258,000, a number which has undoubtedly increased since that time.
- The American Veterinary Medical Association estimates that 40% of households in the United States own one or more dogs.
- Interpolating these numbers means that at least 103,000 households in San Mateo County own one or more dogs.

These animals are family members to us and we deserve to have space to roam and play with them on our public lands. In fact, most dog owners would not even consider accessing our county parks without our dogs.

Our county parks belong to us all and it is government's obligation to find compromise solutions pertaining to access. Thousands of people have signed a petition asking for Fair Dog Walking Access in San Mateo County Parks and we are here today to ask that you do the right thing and open our parks to Fair Access for all.
