They founded Pie Ranch and have taken it from a small farm to a large operation with many employees, a thriving business and educational program and a vital piece of the San Mateo Coast. For many, it is a destination point that brings them to see, enjoy, appreciate and value the rural community of Coastal San Mateo.

To run their farm and programs effectively, as any County farmer and rancher will tell the Commission, residence on the land is critical. Good stewardship of land requires constant presence and so a home on their land is critical for both Jered and Nancy and their family and for the entire Coast as it will guarantee that they will be able to protect Pie Ranch in ways that will benefit the entire community, ways in which they could not if denied a permit and forced to live elsewhere.

The San Mateo coastal, rural community needs affordable, permanent housing. While there are many people who believe in minimizing any coastal development, I would hope that those same people would find tremendous value in recognizing and honoring the agricultural history of the coast and would also hope that they would see that providing farmers a way to live on their land will guarantee good land stewardship and benefit the entire community and Coast.

My wife and I own Potrero Nuevo Farm in Half Moon Bay and live on the property so know first-hand how important that is. In our 7 years here and through our association with all of the County organic farmers, we have learned that affordable, on-site housing for farmers is the most important issue we face in terms of our survival here. Without on-site affordable homes, vibrant young farmers may be forced to leave the area and that seems, to me, not only an insult to the history of farming in San Mateo County, but a blow to the future of farming here as well.

To protect the Coast, the Commission must let Coastal farmers live on their land. To insure a healthy future for farming on the Coast, the Commission must grant permits for on-site farm housing. Please grant Jered and Nancy their permit.
