MATERIALS PRESENTED FOR THE HEARING:

Applicants and members of the public are encouraged to submit materials to staff in advance of a hearing. All materials (including but not limited to models, pictures, videos, etc.) presented by any person speaking on any item on the agenda are considered part of the administrative record for that item, and must be retained by the Design Review Officer until such time as all administrative appeals are exhausted and the time for legal challenge to a decision on the item has passed. If you wish to retain the original of an item, a legible copy must be left with the Design Review Officer. The original or a computer-generated copy of a photograph must be submitted. Five (5) copies of written material should be provided for the Design Review Committee, staff and interested parties.

DECISIONS AND APPEALS PROCESS:

The Coastside Design Review Committee will make a decision when design review is the only application being considered, or make a recommendation to a different decision maker when additional planning applications are associated with the project (e.g., use permit, grading permit, etc.). Decision rulings for a project are appealable to the Planning Commission. Appeals must be filed no later than ten (10) business days following the decision at the San Mateo County Planning Counter (address listed above). Appeal application forms are available online and at the Planning Counter. The appeal fee is \$639.83 which covers additional public noticing.

Consideration of Design Review Permit to allow construction of a new 2,903 sq. ft., 2-story, single-family residence, plus a 528 sq. ft. attached 2-car garage, on an existing 6,500 sq. ft. parcel. Certificate of Compliance (Type A) is pending to confirm parcel legality. Nine (9) significant trees are proposed for removal. Consideration of design review recommendation to allow construction of a 585 sq. ft. second floor addition that includes a 417 sq. ft. master bedroom and 168 sq. ft. rear deck and stairs, to an existing 1,286 sq. ft., 1-story single-family residence, located on an existing 4,900 sq. ft. developed legal parcel, as part of a staff-level Coastal Development Permit (CDP) and Home Improvement Exception (HIE). The HIE is required pursuant to Section 6531 of the Zoning Regulations to allow the second floor addition to encroach 5 ft. into the minimum required left side setback of 10 ft. The Coastside Design Review Committee will not render a decision, but will make a recommendation regarding the project's compliance with design review standards. The CDP and HIE decisions will take place after August 13, 2015. No trees are proposed for removal.

Consideration of design review recommendation to allow construction of a new 1,724 sq. ft., 2-story, single-family residence, plus a 400 sq. ft. attached 2-car garage, and a 551 sq. ft. second unit, on an existing 6,150 sq. ft. legal parcel, as part of a hearing-level Coastal Development Permit. The Coastside Design Review Committee will not render a decision, but will make a recommendation regarding the project's compliance with design review standards. A decision on the design review and Coastal Development Permit will take place at a later date. No significant trees are proposed for removal. The project is appealable to the California Coastal Commission and is scheduled for reconsideration from the July 9, 2015 meeting.
