I believe Cal Water was going to arrange to meet with Mr. Couch at the site in the next couple of weeks after the community meeting. 



Dear Lisa and Steven.

I have been informed that the next hearing for the proposed tank project will be on October 3, 2015. As with the last public hearing the County failed to provide notice of the hearing.

In preparation for the hearing I request that the County provide a written opinion from the San Mateo County Attorney providing the legal basis that the County can issue a permit for construction of a portion of the proposed project on property that is not owned by the County or the water company, but is in a right of way within Palomar Park. In the opinion the issue of the legality of the existing pump house also not on property owned by the County or the water company needs to be addressed. The continuation of the process for the proposed location is of particular concern since I offered an easement entirely on my property to allow the installation of the tank. This was rejected by the water company without doing any engineering for the site stating that they used only aerial data to evaluate the site. In addition the water company representative stated that they would have to restart their capital budget process in the future if the location were changed which would delay the installation as the current funding can only be used for the proposed location. I do not believe the water company has done their due diligence on the offered site and should be required to perform a complete engineering analysis of the site.

If the County determines it has the authority to issue the permits how will the proposed property utilization by the water company be recorded in the County records?

I have spoken to my insurance company and was informed that there is no policy that they can issue to protect our property and the adjacent property. To provide insurance protection both properties must be listed an additional insured on the water company policy or if the company does not have such a policy that a policy be obtained. The policies must be carried with the properties in the future regardless of the future change of owners. The area is classified in the 10 fire risk area will the tank installation if permitted change the classification to a lower rating?

Should the County determine they can legally issue the permit to the water company the water company must be required to provide screening to obscure the view of the tank from my property and to install sufficiently engineered water facilities to divert any water leakage away from my property which is immediately below the tank location. I have provided photos of the grade differential at the previous hearing and request they be included in the record for this second hearing.

Previously the water company representative has stated that this tank provides redundancy for maintenance and is not necessary for daily water supply. Since this is not needed for daily service and is purely to facilitate water company maintenance I do not see a compelling need for the installation that is opposed by the neighbors and community association. I look forward to responses to the preceding issues prior to the hearing on October 3, 2015.

Thank you for the reply. I fail to understand why you have been advised to wait until the public hearing which I will be unable to attend to respond to the issues raised in my letter. This is a case of a lack of transparency and utter disregard of resident questions which I find unacceptable.

The staff report contains many inaccuracies:

- 1 I have reviewed the referenced maintenance map (screen shot of Loma Court attached). The limits of County maintenance shown on the map are not in accordance with the posted limits of the maintenance as shown in the attached photo and the photo of the maintenance crack sealing. By practice the County has not maintained Loma Court to the limits on the map since Loma Road was not constructed to the limits shown on the map to a nonexistent circle. It is obvious that Loma Court has not been maintained beyond the posted sign in the picture which does not include the property which the County would issue a permit to the water company. In fact the area of Loma Court beyond the sign is not constructed as the same width as the lower portion of Loma Court. If the section were constructed and maintained the issuance of a permit would be for an area of paved and maintained road. If the County continues to assert this is a County maintained street immediate repairs are needed. The same is true of Los Cerros Road at the lower boundary of my property which is also shown as maintained by the County in the Board of Supervisors referenced resolution but in that case is an unpaved dirt road. Not only is staff making improper statements but the Board of Supervisors has approved an incorrect map that was not even included with the Board action to give the information to the Board upon which to act. This must be corrected on the County map and brought back to the Board of Supervisors for approval stating the incorrect information. Until this is done the public hearing must be postponed and the staff report corrected based on an updated and Board approved map.
- 2 The question on fire area has not been answered.
- 3 The issue of adding both properties to the water company insurance has not been answered.
- 4 The lack of County notification of the hearing has not been answered.
- 5 There is no opinion from the County Attorney

- 6 Where in the County records is the road platted?
- 7-Why is the project necessary?
- 8 Why was the offered site not properly evaluated?

Since I will not be able to attend the September 3, 2015 hearing and the County has not provided proper notification nor a response to the questions in my letter I request the hearing be rescheduled to allow time for a reply by the County and proper notification.. Additionally I do not see how the action could go forward without correcting the maintenance map and obtaining Board of Supervisors approval which must include the identification of the error and the effect on this proposed project.

I would hope the County favors an open and transparent proves with full community involvement.

Hi,

Background: We are long time residents of Palomar Park and San Mateo County. We are familiar with local water & fire issues, building codes and other relevant things. Silvia is an Electrical Engineer at Qualcomm while i'm a semi-retired Scientist (ex-Tyco Electronics, Raychem, etc..).

In addition, I know well the potential fire hazards of very steep & tree'd semirural residential areas after living in the Oakland Hills (Mom's house, which was spared in the big fire of 1991),

Lastly for full disclosure, I am also an elected Director of the Palomar Property Owners Inc., but am submitting this solely as a citizen. (A formal PPO opinion on this couldn't be resolved prior to today; FWIW, the June'15 PPO BOD consensus was *for* this project.)

Our Comments: After reviewing all relevant documents and correspondence made available to the PPO group, have inspected the site (w/ report & building plans in hand), have attended the March Public meeting at the Vian's house, have discussed details & generalities at length in the PPO BOD and separately.

Our honest opinion is that the required codes, procedures, specs, calculations, and *reasonable* response (or modifications) to mitigate *reasonable* neighbor concerns have been met with the current project plan (steps, parking pad, etc..) and *this project permit should be approved*.

Further, our opinion is that the drainage, geotech destabilization, above ground power line, etc.. worries and concerns neighbors highlighted are well in excess of the "*true risks*" if the project is implemented as currently engineered, designed and presented. (This after considering the various potential negative impacts & probabilities of each, and also if a "doing nothing at this site" alternative is compared).

Scientists & engineers have many tools to assess "risks, impacts, likelihoods" of any project, based on the data available (e.g. FMEA, etc..); the only "concern" that is at all new & significant (vs doing nothing) is "Damage from tank leakage or overflow." While impact would be high, available facts indicate probabilities for these failure modes is extremely low, so the "real" accumulated risk is also very low, and therefore acceptable.
