Where it is now seems to be a fair distance from the homes on Wildwood Lane so I think the notion leaving it there with smaller equipment and better insulation to reduce the noise would make a lot of sense. I would also say that safety on our frontage road is a much bigger issue to me than the AT&T equipment. Closing off one end and making the street into a cul-de-sac seems like something that should strongly be considered to ensure the safety of cyclists, pedestrians and motorists. Visibility on the southern end is terrible and cars shouldn't be allowed to exit there (and accidents have certainly happened as a result). A traffic light would be great, but since I don't think that is an option closing off the unsafe end seems like a reasonable solution to me.
