- A new statewide Septic System Policy recently went into effect that requires County of San Mateo to update the current Septic System Ordinance and the related on-site systems manual. Over the past year, Environmental Health Services staff have worked with industry and jurisdictions representatives to draft proposed changes to the County's Septic System Ordinance. Environmental Health staff are now working to introduce proposed changes to interested parties, answer questions, and seek feedback related to the state-mandated updates. This item is informational only to the AAC. The proposed ordinance is anticipated to be presented to the County Board of Supervisors for approval at their regular December 8, 2015 meeting.

Greg Smith, Environmental Health Supervisor of Water Protection and Land Use Programs will present proposed updates to the Septic System Ordinance that are relevant to the Agricultural Advisory Committee.

#### 4. Public Announcements/Comments for Items not on the Agenda

- 7:31 Ben Wright of the Peninsula Open Space Trust introduced himself.
- 7:32 Kerry Burke announced that the County Government sent out Williamson Act questionnaires.
- 7:34 BJ Burns passed out excerpts from the PAD Chapter of the Zoning Regulations that included Section 6365, which established the Agricultural Advisory Committee.
- 7:36 Bob Marsh proposed sending an AAC member to the Planning Commission.
- 7:38 Fred Crowder reported on the Crop Report.

#### 5. Answer to 513 Stage Road Inquiry About Ongoing Work

- 7:41 Steven Rosen described the permits issued for development at 513 Stage Road as requested. The attendees asked why the Agricultural Advisory Committee did not have the opportunity to review the Coastal Development Permit Exemption and administrative Building Permits and discussed why it should have been referred to the AAC. Bob Marsh announced that he would visit the Planning Department and report back to the AAC.
- 6. 1) Consideration of a Coastal Development Permit (CDP) and a Planned Agricultural Permit, pursuant to Sections 6328.4 and 6353 of the San Mateo County Zoning Regulations, to amending an existing Farm Labor Housing permit for two new Farm Labor Housing units, each approximately 1,700 square feet in size and; 2) the renewal of the Farm Labor Housing permit for eight existing units on the property. The property is located in the unincorporated Rural Midcoast area of San Mateo County. The CDP is appealable to the CA Coastal Commission.
- 7:57 Steven Rosen presented two pages of the staff report.
- 7:59 The Agricultural Advisory Committee noticed that the staff report stated that there were no prime soils found on the site, but that there is prime agricultural land. It discussed the difference.

- 8:05 BJ Burns moved to recommend approval of the project as proposed.
