#### MATERIALS PRESENTED FOR THE HEARING:

Applicants and members of the public are encouraged to submit materials to staff in advance of a hearing. All materials (including but not limited to models, pictures, videos, etc.) presented by any person speaking on any item on the agenda are considered part of the administrative record for that item, and must be retained by the Design Review Officer until such time as all administrative appeals are exhausted and the time for legal challenge to a decision on the item has passed. If you wish to retain the original of an item, a legible copy must be left with the Design Review Officer. The original or a computer-generated copy of a photograph must be submitted. Five (5) copies of written material should be provided for the Design Review Committee, staff and interested parties.

#### **DECISIONS AND APPEALS PROCESS:**

The Emerald Lake Hills Design Review Officer will make a decision when design review is the only application being considered, or make a recommendation to a different decision maker when additional planning applications are associated with the project (e.g., use permit, grading permit, etc.). Decision rulings for a project are appealable to the Planning Commission. Appeals must be filed no later than ten (10) business days following the decision at the San Mateo County Planning Counter (address listed above). Appeal application forms are available online and at the Planning Counter. The appeal fee is \$616.35 which covers additional public noticing.

Consideration of Design Review recommendation of construction to allow a new 4,171 sq. ft. single-family residence, 3,422 sq. ft. with an attached 749 sq. ft. garage, on a 13,946 sq. ft. legal parcel. Twenty-four significant trees are proposed to be removed. An existing shed on the site will be demolished. The application requires a staff-level grading permit for 410 cy. of earthwork. The Design Review Officer will not render a decision but will make a recommendation to the Community Development Director. A decision on the grading permit will occur after January 2, 2018.

Consideration of Design Review recommendation to allow construction of a new 6,761 sq. sq. ft. single-family residence (5,932 sq. ft. with a 829 sq. ft. garage) on a 28,328 sq. ft. legal parcel. One significant tree is proposed to be removed. The existing residence is to be demolished. The project also requires a staff-level grading permit for earthwork in the amount of 951 cubic yards and a Fence Height Exception to allow a six-foot fence in the front yard where four-foot is the limit. The Design Review Officer will not render a decision but will make a recommendation to the Community Development Director. A decision on the grading permit and fence height exception will occur after January 2, 2018.

Consideration of Design Review recommendation to allow construction of a new 4,359 sq. ft. single-family residence (3,831 sq. ft. with a detached 528 sq. ft. garage) on a 22,551 sq. ft. legal parcel. Eight significant trees are proposed to be removed. The existing residence is to be demolished. The project also requires a staff-level grading parcel for earthwork in the amount of 635 cubic yards. The Design Review Officer will not render a decision but will make a recommendation to the Community Development Director. A decision on the grading permit will occur after January 2, 2018.
