

*Written Comments:

Members of the public may provide written comments by email to <u>drobinson@smcgov.org</u>. and should include the specific agenda item on which you are commenting or note if your comment concerns an item that is not on the agenda or is on the consent agenda.

The length of the emailed comment should be commensurate with the 5 minutes customarily allowed for verbal comments, which is approximately 300-400 words. To ensure your comment is received and read to the Zoning Hearing Officer for the appropriate agenda item, please submit your comment no later than 5:00 p.m. the day before the meeting. The County will make every effort to read emails received after that time but cannot guarantee such emails will be read into the record. Any emails received after the deadline which are not read into the record will be provided to the Zoning Hearing Officer after the meeting and become part of the administrative record.

MATERIALS PRESENTED FOR THE HEARING:

Applicants and members of the public are encouraged to submit materials to staff in advance of a hearing. Decisions made by the Zoning Hearing Officer are appealable to the Planning Commission. The appeal fee is \$616.35 which covers additional public noticing. Appeals must be filed no later than ten (10) business days following the decision by contacting Debra Robinson at <u>drobinson@smcgov.org</u>. The Appeal date for this meeting is September 18, 2020.
