SUBJECT: STAFF REPORT ADDENDUM: Consideration of a Minor Subdivision,

pursuant to Section 7002 of the County Subdivision Regulations to subdivide a 11,780 sq. ft. parcel into four townhouse units and one common interest parcel at 20 Dexter Avenue in the unincorporated North Fair Oaks area of San Mateo County. The project includes the removal of

one 30-inch dbh (diameter at breast height) redwood tree.

#### **PROPOSAL**

The applicant proposes to subdivide an 11,780 sq. ft. legal parcel into four townhouse units and the airspace above and one common interest parcel as shows in table 1. The purpose of the subdivision is to construct 4 townhomes to be sold off separately. The townhomes would be 3 stories and all units would have a shared access off of Dexter Avenue. One 30-inch (DBH) redwood tree is proposed for removal due to poor health and proximity to the proposed structures.

## **RECOMMENDATION**

Staff recommends that the Zoning Hearing Officer proceed with the public hearing as scheduled on December 17, 2020 to allow interested parties an opportunity to comment on the project, but continue consideration of the Minor Subdivision, County File Number PLN 2020-00097, to allow for review by the North Fair Oaks Community Council at their

January 28, 2021 meeting.

#### **BACKGROUND**

The project was deemed complete on October 30, 2020. A request to add the project to the North Fair Oaks Community Council's (NFOCC) November agenda for review and recommendation to the Zoning Hearing Officer (ZHO) was unable to be accommodated because the agenda was full. Since the NFOCC does not meet in December, the next available Council agenda date for this project would be January 28, 2021. In order to avoid an approximate three-month delay, staff moved forward in scheduling the project for the December 17, 2020 ZHO public hearing. A notification of public hearing and copy of the staff report was provided to the Council.

# **DISCUSSION**

As of December 14, 2020, several members of the NFOCC, including the Council Chair, have requested that the project be forwarded to the NFOCC's next regularly scheduled meeting on January 28, 2021 to allow the Council the opportunity to publicly review and address questions and concerns on the project before it is considered by the ZHO.

## CONCLUSION

Based on request from members of the NFOCC, staff is providing this revised recommendation to the ZHO to proceed with the public hearing on December 17, 2020 to allow interested parties an opportunity to comment on the project but continue consideration of the project to a future date in order to allow the NFOCC an opportunity to review the project at their January 28, 2021 meeting.
