# MATERIALS PRESENTED FOR THE HEARING:

Applicants and members of the public are encouraged to submit materials to staff in advance of a hearing. Appeals must be filed no later than ten (10) business days following the decision by contacting Debra Robinson at <a href="mailto:drobinson@smcgov.org">drobinson@smcgov.org</a>. The appeal date for this agenda is April 1, 2021.
